

This East Central Community Development Neighborhood Report summarizes our Steering Committee's recommendations for the expenditure of \$133,570.00 in 2005 Community Development Block Grant funds.

Since the East Central Neighborhood incorporated with the State of Washington September 10, 1980, the East Central Neighborhood has been a Community Development Neighborhood. Through participation in this City of Spokane program, the Steering Committee recommends allocations for the expenditure of Community Development Block Grant (CDBG) funds to benefit our Neighborhood.

The City of Spokane is eligible to receive these funds through the Department of Housing and Urban Development. Our neighborhood is eligible based on U.S. Census information that indicates that the majority of the residents living within our boundaries have low and moderate incomes.

Again this fall, our Steering Committee has selected projects and programs that will use our Neighborhood's portion of the block grant for the benefit of low and moderate-income residents in our neighborhood. Our selections reflect the results shown on our Neighborhood's Needs and Priorities Worksheet, which was completed by persons requesting dump passes from our neighborhood cleanup and participants in our neighborhood planning efforts. A copy of the results is included in this report.

Our Steering Committee meetings are held on the third Tuesday of each month at the East Central Community Center at 6:45 PM. Our Executive Board meets on the first Tuesday of each month, please contact us for time and location.

At each of our Steering Committee meetings, our Neighborhood Coordinator and Secretary provide meeting minutes, agendas, and rosters to all in attendance. We have also provided for information and articles in the East Central Neighborhood Newspaper, and the Southside Voice supplement to the newspaper to advertise the Spring and Fall meetings.

We are always seeking ideas for get residents involved in the Steering Committee. Occasionally, we contact members using a "telephone tree," with members responsible for calling other members. That method of communication works especially well to inform members of special meetings. Our neighborhood has also begun using the Internet to communicate with members and interested parties through the use of email list and the website provided through the Office of Neighborhood Services

We appreciate everyone who has been involved this past year. We are continually striving to make the East Central Neighborhood a great place in which to live and work.

Summary of the 2004 East Central Steering Committee meetings:

January 20, 2004:

Gary Nelson, Spokane City Engineering Services, reported that the City has funds for preliminary engineering and right-of way planning for a proposed bike path to link the Ben Burr and Centennial Trails. Members were encouraged to attend the U-District planning meetings. Neighborhood Planning Stakeholders began meeting on January 29th.

February 18, 2003:

Rick Dullanty and Jon Tonani (Hico Markets) presented plans for several small businesses leasing different parts of the vacant Excell building to provide an array of services. Services include a convenience store with fresh produce, gas pumps and a Laundromat / dry cleaners. Neighborhood Planning Open House was held on Tuesday, Feb. 24th at ECCC. CD funds were used to mail a newsletter to 7,500 neighborhood residents and businesses announcing the neighborhood-planning kickoff.

March 16, 2003:

Theresa. Brum reported that the CDBG-funded inventory and history of 300 buildings in the Grant Park area has been completed. Group decided to begin work to create a historic district in the Grant Park area. City requested \$1,500-2,000 of neighborhood CD monies to extend the sidewalk at the bottom of Altamont hill to close off a dangerous dirt access point running east to 8th Street. The Steering Committee also approved spending \$880 to place planters on the spur rather then the city proposed concrete barrier. Paul Cramer reported that EC is considered one of the top three neighborhoods out of 26 neighborhoods in the City in terms of participation and cost-effectiveness of our cleanup efforts.

April 20, 2003:

Michelle Preston with Habitat for Humanity thanked ECNSC/C for continuing CD support to help acquire properties for home construction in the neighborhood. Planning for the Senior Housing development on 5th by Kiemle-Hagood on the vacant half block across from the Community Center is starting up and a neighborhood advisory group will be re-activated. More than 300 people attended the U-District planning meeting at AVISTA, showing positive energy with lots of consistency among the individually expressed visions.

May 18, 2004:

June Martin presented a report from WSU Human Services Planning summarizing needs and resources information collected from a series of focus groups in ECC and Chief Garry neighborhoods. Jonna Boxley of the Public Facilities District present the plans for the Convention Center Expansion. Randy Palmer made a presentation about the Work Crew operating out of the Community Corrections Center on Sprague. Spokane County sponsored a Wastewater Treatment informational meeting at ECCC on May 12. The City has acquired Playfair as a potential site for a water reclamation and treatment facility.

June 15, 2002:

Paul Cramer reported the Neighborhood Cleanup from for first half of funding cycle: 80 appliances removed from 49 houses in May; \$2,655 curbside pickup in S. Perry and Liberty Park areas. Michelle Preston summarized Bridging the Valley proposal in terms of its impact on EC neighborhood. The plan proposes to reduce railroad crossings through consolidation of lines, closure of street-grade crossings, and construction of over and under passes. If funded, an overpass at Havana and RR tracks would be constructed. Members were shown a Powerpoint on a city-sponsored trip that Numbers, Wojtulewicz and a representative from Chief Garry made to view a Vancouver, Wa. waste treatment facility. Susanne Croft (City Planning) summarized the Centers & Corridors part of the East Central neighborhood planning effort. The City Comprehensive Plan seeks to focus growth in existing centers and corridors so as to protect single-family residential neighborhoods while also maximizing use of public infrastructure investment by creating more services within walking distances of neighborhoods

July 20, 2002:

Steering Committee / Council summer break

August 17, 2002:

KC Traver and Molly Myers presented plans for the light rail project to link Spokane's downtown to the Spokane Valley. The plan builds on already existing railroad right-of-way and what has been learned from light rail projects in other communities. Several alternatives are being considered: 1) dual track electric (most expensive) 2) single-track diesel rail (less expensive) 3) premium bus rapid transit, in which buses have preferential treatment at intersections (lowest cost, but few models to demonstrate economic development spinoff) 4) combination of light rail and bus rapid transit (main negative is need to transfer) 5) a scaled-down proposal to implement the lowest cost per mile approach at priority location and phase in extensions as funding becomes available 6) take the "low frills" approach described in 5) and implement it for the entire corridor.

September 21, 2001:

June Jones reported on Centerpoint, one of the projects partly funded by steering committee funds. Centerpoint has served people with disabilities for over 50 years and provides a variety of activities for more than 300 people per week. The 5th Ave Senior Housing Project committee reported it will help develop the funding application, work with the nonprofit and Kiemle-Hagood through the construction period, as well as recommend the composition and structure of the single-purpose 501c.3 entity that will then assume responsibility for operating the housing project.

October 19, 2004:

Allocations Committee formed, materials handout and discussed. Paul Cramer reported our neighborhood cleanup efforts have removed 125 tons of garbage from the neighborhood over the past 3 years. City Council Person Mary Verner was in attendance.

November 16, 2001:

The Allocations committee presented their proposed allocation budget for 2005. Members in attendance discussed the proposal and after some discussion the 2005 allocations budget was adopted. Linda Yeomans reviewed the areas in the neighborhood that have already been inventoried and recommended adding 50 more houses for inventory into the S. Perry District study. ECNSC/C membership had voted to add 50 homes to the survey and implement national historic designation of S. Perry as a district.

In addition to attending monthly meetings, representatives from our Steering Committee attended the CD Public Hearings, City Council Meetings, and other meetings pertinent to our Neighborhood. Our Community Development Neighborhood Coordinator attended monthly meetings with the CD Staff. We have worked to develop a liaison with the business community, the schools, and the residents of the Neighborhood. Every effort was made to include the community we represent through monthly meetings, newspaper articles, and neighborhood flyers.

Other requests will be made of the CDNC's time as needed.

Communications -- \$4,000

Keeping the residents of our neighborhood informed is essential in keeping them involved. A budget for printing and mailing of meeting announcements, meeting minutes and newsletter mailings for spring and fall meetings is needed to provide information to our residents of upcoming activities and events.

Neighborhood Historic Survey -- \$10,000

Funds will be used to continue the inventory historic structures in the East Central Neighborhood and where possible create historic districts. CD Funds will be used to contract with a historic preservation consultant through the Office of Historic Preservation

Neighborhood Planning -- \$2,500.00

CDBG funds will be used to facilitate development and publication of a neighborhood plan to meet the cities requirement under the Comprehensive Plan.
