a. City Council Report:

Councilwoman Kinnear:

- March 8th & June 12th Comprehensive plan Open Public Comments at City Hall in the City Council Chamber
- Kinnear working on the demolition ordinance for Spokane, specifically around historic structures.

Councilman Fagan:

- WSDOT project reach out to the interim fire chief to have local fire chiefs be on a heightened alert so that they are ready to respond to emergencies.
- WSDOT speeding, reach out to the chief about people trying to by-pass construction and speeding through the neighborhood. Ask for additional support from police in the neighborhood during WSDOT's construction. Consider placing the mobile speed feedback signs in the neighborhood during construction.
- Signalization (Altamont), work with City Engineer staff to better time intersection signals.
- Service Animal Forum: Next meeting at the Hillyard Senior Center from 11am-12m.

b. Street Vacations – West Southwick and Nick Czapla from Playfair Commerce Park & SAFCO

- Two new street vacation at SCAFCO.
- Each project will include landscaped areas with irrigation and trees and walkable paths from Alki Ave./Freya to Altamont.
- Neighborhood Resolution to support the street vacation
- Motion to support the Resolution of the SCAFCO street vacation.

c. Community Court Expansion - Mary Logan, Judge

- Community Courts are a problem-solving court system. The Community Court uses
 unique processes to get people resources in the community. The Community Court is
 going to expand out of the downtown area. They have received a grant to do this
 expansion. They are trying to determine where they will relocate. Services are
 available to everyone in the community not just addressing crime.
 - What are the top crime issues that our neighborhood faces? Top 5 priorities.
 - Prostitution
 - Drug- trafficking selling and using drugs
 - o Squatters people that move into abandoned homes, malicious mischief
 - Vehicle prowling breaking in to cars and theft
 - Graffiti
 - Property Crime breaking and entering and theft (home and garage)
 - Domestic violence
 - Panhandling
 - In a traditional court system, it takes more time to resolve these types of crimes.
 - Community Court is held once per week and people are required to meet each week.
 - A resolution in support from the neighborhood and the business districts would be helpful to get Community Court to expand to East Central Neighborhood.
 - Discussion with JJ, Executive Director of the East Central Community Center (ECCC), has taken place to move Community Court to the ECCC building.
 - Motion: ECNC will write a letter of support for Community Court to come to the East Central Community Center.
 - Unanimous

d. County Sales Tax - Nancy Voermans

- Proposition 1: 1/10 of a 1% sales tax that covers emergency systems. Impact is
 county wide and is \$1 per household per month (\$12 per year). They are looking to
 purchase new radios, new car tracking systems, systems and first responders, crime
 check, alert Spokane (non-emergency calls and 911). Support to facilities; backup
 center for disaster response, 22 communication towers.
- Crime check took in approx. 240,000 calls in 2016.
- Timeline: April 10th ballots sent out to the public.

e. WSDOT Project at I-90 and Hamilton - Chad Simonson, Project Engineer

- WSDOT Project bridge preservation project to replace expansion joints on the I-90 viaduct in the EB direction at the mile post 280.9 and in the EB & WB direction at the mile post 281.33
- STAGE 1 (May 7th May 26th): Work on the east bound traffic inside lanes on the 3rd
 Ave Bridge. During this stage, traffic will be reduced to 2 lanes in the east bound

- direction from west of Arthur St. to west of Thor St. The Altamont on and off ramps will be closed during this stage and during stage 2.
- STAGE 2 (May 30th June 22nd): This stage will include all work in the east bound outside lanes on the 3rd Ave. Bridge as well as all the east bound work on the viaduct and all west bound work for both bridges.

- Traffic calming project purpose slow traffic and implement safety measures.
- Residential traffic calming projects need to get signatures from residents within 400 feet of the project location and 50% support needs to be achieved for the project to be approved.

- They need to be ranked from top to least priority by the neighborhood.
